At this time there are no reference standards available for (+)d8-THC. (+)d8-THC is a different compound from the main (-)d8-THC canabinoid and, therefore, these two compounds may have aliferent efficacies. Using the most advanced instruments and techniques available, the separation of (+)d8-THC and d9-THC is a combination of (+)d8-THC and d9-THC and d9-THC and d9-THC with the majority, if not all, of the concentration being (+)d8-THC.
